What does the schedule look like?

What is included in this trip?

Airfare:

Tier 1 Qualifiers: Airline Ticket for 1

Tier 2 Qualifiers: Airline Tickets for 2

Tier 3 and above Qualifiers: Airline Tickets for 2, arrive 1 day early, cash

****Note** - Your market location determines how much LifeVantage contributes to each flight.

The amount(s) per ticket are as follows:

- \$1400 USD US, Canada, Mexico, UK, Netherlands, and Germany
- \$2000 USD Taiwan, Hong Kong, Thailand
- \$2200 USD Australia
- \$2300 USD Japan

Any cost that exceeds these amounts, you are responsible to cover.

Transportation:

LifeVantage will provide transportation for you and your guest from the airport to your hotel in Killarney. For early arrivals or trip extensions, please make separate transportation arrangements

Hotel Accommodations:

Attendees will be staying at one of the two participating hotels. Lodging costs and taxes are covered for qualified dates.

Meals:

Meals will be paid for and served according to the following schedule.

Welcome Gifts:

You will receive a welcome gift when you check in with LifeVantage.

Additional Funds :

You will receive additional funds in your Hyperwallet account in August to offset the cost of meals during the trip that aren't covered by LifeVantage. Please note, the amount is based on the average costs of meals in Ireland.

What is not included in this trip?

Extra Airfare:

You are responsible for any airline costs that exceed the amounts LifeVantage will provide.

Transportation:

You are also responsible for transportation costs associated with events outside of the Incentive trip schedule. Additionally, you are responsible for rental cars, taxis or any other form of transportation during the trip.

Hotel Accommodations:

LifeVantage will not cover any of the following:

- Additional hotel nights outside of the nights qualified for
- Additional room charges (e.g. room service, laundry service, etc)

What should I pack?

Average August temperatures in Ireland fluctuate between 64 and 68 °F (17 and 20 °C). Here are a few things we suggest bringing:

- Rain Coat
- Pairs of sturdy and or athletic shoes
- Rain boots
- Warm clothing (sweaters, jeans, scarf, hat, gloves, socks)
- Comfortable workout clothes for one of the group activities
- Sunscreen
- Travel adapter and/or converter
- **Tier 3 and above:** 1 business casual outfit for dinner on August 25th

What is the buy-in cost for additional guests?

For Tier 1 Qualifiers: Tier 1 Qualifiers are responsible for purchasing their guest's airline ticket. LifeVantage will cover the rest of the guest's costs, including activities, LifeVantage-provided meals, and airport transfers.

For all Qualifiers: Due to limited room availability, we are not offering buy-ins for a third guest and beyond. If accommodations open up, we will notify you after registration closes on June 19th. To be added to the buy in wait list, email irelandrooms@museem.com.

What if I want to arrive early/extend my stay?

You are welcome to extend your trips (at the beginning or the end). However, LifeVantage will not cover any airport transfer costs outside of the regular schedule, and rooms at our participating event hotels can only be booked if the hotel has capacity to do so. Please contact irelandrooms@museem.com to inquire about extended room nights.

If I've earned the Ireland Incentive Trip but cannot go, can I receive a substitute reward or allow someone to go in my place?

Unfortunately, no. This trip is nonrefundable (no cash outs) and non-transferable.

If I am a cash earner, when will I be receiving my payout?

Cash payouts will be available in your Hyperwallet account during the month of August. It will appear separately from any monthly commissions.

Why am I required to book my flight(s) through American Express Travel?

Our partnership with American Express provides a one stop shop for booking travel with access to all major airlines. Once registered, please call American Express and provide the meeting number to book flights.

****NOTE- LIFEVANTAGE WILL NO LONGER REIMBURSE QUALIFIERS AND GUESTS FOR FLIGHTS BOOKED ON THEIR OWN.**

Is a Tier 1 qualifier's guest required to book their flight through American Express Travel?

No. Because LifeVantage is not responsible for the cost of this flight, please feel free to book with any carrier. If guests decide to book elsewhere, send their flight itinerary to irelandrooms@museem.com, no later than **June 21, 2019** with the subject line "**Tier 1 Guest Flight Itinerary**", and the name of the qualifier who the guest will accompany. Without this information, we will not be able to reserve transportation from the airport to the hotel.

What if I miss my flight?

Is this trip included in my year end totals for tax purposes?

Yes, the value of the trip will be included in your 1099. The amount that appears on the 1099 will be based off the qualifying tier.
